#### **BACKGROUND**

Enclosed is the final agreement between OTC, City of John Day, and Grant County Digital for Internet Services related to the 2019 USDA ReConnect Grant.

This agreement has been amended to include all three parties as signatories, with an updated severability/survivability clause (last term of the agreement), which would allow City or Grant County Digital to assume sole responsibility for the agreement obligations in the event these signatories reach an agreement to sever their relationship, either through the dissolution of Grant County Digital as an ORS 190 organization, or through the separation of Grant County Digital from the City.

Staff will review the terms of the agreement during this agenda item and we can discuss the options for future transition of Grant County Digital under Other Business.
